



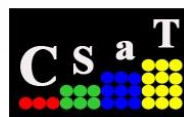

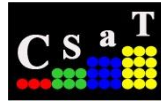

# AHC21216 CERTIFICATE II IN RURAL OPERATIONS

## COURSE CONTENT:

This qualification provides an occupational outcome for industries and agencies in rural and regional Australia. Industry experts expect individuals to carry out routine tasks under general supervision and exercise limited autonomy with some accountability for their own work.

*There are no entry requirements for this qualification.*

Before commencing in this qualification, learner's proficiency in language, literacy and numeracy will be assessed to determine what level of support may be needed throughout the study program.

**Duration:** 18 – 22 months

**QCE Points:** up to 4 (based on completed qualification)

This qualification is currently delivered via **classroom and workplace** delivery. Students may be required to complete some theory work in their own time. Assessment methods will include written, observation, and projects.

The payment/funding option for this qualification is:

- Fee for Service (payment plans are available)
- **VET in Schools - VETiS (funded by the Queensland Government)**
